



We are working with an Environmental Consultancy Firm from a professional perspective.





#### AN EMPLOYEE POLICY AGAINST ALL FORMS OF DISCRIMINATION

- It recruits competent personnel without discriminating against racism, religion, gender, age and similar issues.
- Help plans/organizes events.
- We have added awards in areas such as "environmental awareness, compliance with Occupational Health and Safety rules, guest satisfaction, and contribution to sustainable tourism".

- It organizes awareness trainings on mobbing, child abuse, women's rights and human rights. Provides training of personnel.
- Makes performance evaluations.
- The location of the staff lodging was chosen from the closest location to the hotel. Thus, it is aimed to reduce the carbon footprint.
- We aim to increase the number of our local employees to 70% next year.

You can see the care we take to protect our local vegetation wherever you look when you enter within the borders of **LE MERIDIEN BODRUM BEACH RESORT.** 

#### With our landscape team, mostly consisting of local people;

- ✓ We do our landscaping by protecting local plant species.
- ✓ We use treatment water in field irrigation to protect fresh water resources.
- ✓ The Bermuda grass we use is a type of grass that is resistant to heat and drought.
- ✓ We use environmentally friendly products such as fertiliser etc. in our green areas.
- ✓ Humic acid (The main content of organic matter in the soil is humus. Humic acid is the most active substance of humus), we prevent the soil from becoming barren.
- ✓ Our irrigation system is managed through an irrigation control unit to prevent water loss.
- ✓ We prevent water waste and mineral loss of the soil by adjusting the minute according to each tree and the region of the lawn, using drip and sprinkler systems according to the location.
- ✓ In our green area decorated with jujube, mountain strawberry, oleander, olive, mulberry, acacia, pine species, mule's claw, immortelle and wonderful bougainvillea, full of bird chirps, we ensure that you live in peace by protecting the natural ecosystem and respecting all living things.
- ✓ Our goal is to carry it to the future without any loss of local vegetation.



### A Policy Against Paper Waste

In the Sustainable Tourism process; the practices carried out by the Accounting department inspire other departments.

- When printing paper, we make sure that no colour printouts are made.
- When we print, we print on two sides, avoiding paper waste.
- The oversized envelopes used for departmental reports received in the morning are reused until they are worn out.
- Our goal is to discover applications that will make it possible to store data in a computerised environment and reduce our use of paper and cartridges in 2025.

### ENERGY EFFICIENCY POLICY

• In order to protect our world from possible dangers, we use our energy efficiently and set targets to reduce our energy consumption.

#### For this;

- We follow national and international standards, laws and regulations in order to fulfill both our responsibilities towards nature and our legal obligations, we voluntarily carry out studies to reduce energy use and/or continuously improve our energy consumption performance, and we monitor the results of our studies.
- We set goals and include energy efficiency in our training programs in order to ensure the participation of our employees.

- We care about cooperating with all our stakeholders to create common goals and results in energy management. We try to maintain our interaction with our guests, employees, visitors and all business partners in order to reach a level of awareness and consciousness on these issues.
- We try to find, purchase and use energy efficient suitable products, equipment, equipment and technology alternatives.
- We aim to document our Energy Management System, to disseminate it to all our departments, to update, review and continuously improve when necessary.
- We evaluate energy risks or emergencies such as energy constraints, and plan the measures that can be taken.

# WHAT WE DID TECHNICALLY?

- 1. We supported the panoramic architecture, where we can get efficiency from sunlight structurally, with our laminated glasses that absorb at least 85% of UV rays and our good insulation system.
- 2. Thanks to our biological purification system, we save fresh fresh water.
- 3. In addition, we choose our devices from A+ products and provide economical use.
- 4. We follow water and electricity leaks and take the necessary action.
- 5. We regularly monitor energy and water consumption.
- 6. We are planning to prevent 20% water waste by replacing our faucets and shower heads with economical products.
- 7. We aim to reduce the excess electricity consumption by 20% thanks to our sensor and led lamps that we will place at the points we have determined, we have started working.





#### Front office

- We Inform Our Distinguished Guests About Our Sustainability Studies, both verbally and via e-mails, and provide information in order to facilitate the Sustainability Process Contributions to the Welfare of Future Generations.
- We Organize Surveys, Receive Requests, Monitor and Support Our Guests in Contributing to the Sustainability Process.

#### As a front office, our environmental measures,

- We use the back sides of the printouts used for our guests for our note paper needs.
- We do our buggy cleaning with hotel textile products that have been discarted.
- All of our records are kept in the computer environment, we do not transfer documents. (Subjects followed up about our guests, internal correspondence, reservation confirmation documents, etc.)
- As part of Marriott's "Unlock of Art" programme, we support the local "Chocolate Museum" in the port of Karia and inform our guests about the programme.
- We support local employment, the number of local employees in our team is half of the total number. Our goal is to increase this number.



#### Front office

- The maintenance and all the needs of our vehicles are also done by local craftsmen.
- We use as little paperwork as possible when sending information to our guests.
- We send notifications to our Marriott guests via the GXp portal offered by Marriott, to our other guests via Whatsapp and e-mail.
- In our concierge services, we work with completely local businesses rather than national big brands. Transfer company, florist, tour organizations and the majority of restaurants.
- We reduce the use of physical plastic cards by directing our guests to the mobile key application. With Marriott's mobile key application, our guests can enter and exit their rooms with the application on their phones after check-in, thereby reducing both the use of physical cards and the use of envelopes in which the cards are placed.

- In order to reduce the amount of waste, we make bulk purchases in large packages as much as possible.

- We raise awareness of our staff about savings through regular trainings.
- By regulating the use of curtains, we prevent unnecessary air conditioning use.
- We pay attention not to change the hotel textile without a request, in order to contribute to our distinguished guests' support to the nature in terms of water and electricity saving.
- We Contribute to Sustainability by Using Environmentally Friendly Products.

Thanks to the card system in the rooms, we save electricity.
